RE Euthanasia in Victoria

I ask that you do not support the law that is about to come before our parliament.

I write to ask that you not support the legislation to make physician assisted suicide and euthanasia legal in

The moment we accept that there are people who fit a category that makes them eligible for suicide, pressure is placed other people in similar circumstances. People with disabilities, who know they are a burden to others and often face significant challenges already, may feel they should "do the right thing" and ask to be killed. People in pain should receive all the support we can give them. But this law will make it harder for many others who are already live with the burden of a disability. We should not make it harder. RE: Euthanasia and elder abuse

I am against the proposal to introduce euthanasia because it is far to open to abuse.

Doctors are trained to diagnose disease – not detect coercion. It would be very difficult for a doctor without a long history of caring for a patient and knowing all of their circumstances, to be absolutely certain that family members or someone else with a more sinister motive has not influenced the person's decision.

It is equally worrying that if assisted suicide is introduced, people may be given a prescription of deadly drugs to take at some time in the future – possibly a year later. While the decision to ask for the prescription may have been free, nobody can be certain that there will not be pressure when the drugs are actually taken. It seems impossible to make such a law safe. Please, do all you can to prevent this from being introduced.

RE Bill to legalise assisted suicide and euthanasia

I write to express my concern with the government's proposal to introduce assisted suicide and euthanasia. It seems to me impossible that this law will not result in innocent people being killed.

Even with the best intentions, mistakes happen. To think that introducing killing into medical practice will not involve mistakes is unrealistic and naïve. It was for this reason in part, that we stopped using the death penalty in Victoria. Because of human error, mistakes can be made that have tragically irreversible consequences. It is not fair that providing some people a choice to end their life has to come at the cost of the lives of others

who die because of the mistakes that are impossible to rule out. It's just too dangerous. I ask that you not support this law.


