
### Parish Secretary: TWENTY-NINETH SUNDAY IN ORDINARY TIME

The frequency with which we consider the question of insider-outsider is an indication of how important universalism and the breaking down of boundaries is within our religious tradition. All peoples, all lands are called on to praise God. Furthermore, God cares about and cares for all people (see Is 19:25), and God works through all people to accomplish good in the world: Gandhi, a Hindu of Indian origin; Martin Luther King, Jr, a Baptist minister; Susan B. Anthony, a suffragist; Nelson Mandela, a Black South African, etc. Human beings have always realised that, in comparison with the grandeur and expansiveness of the universe within which they live, they If

offer homage to a divine being, or beings. Praise of God has always been an expression of awe and gratitude as well as humility.



# DIFFERENT VIPUS A simple question?

gospel passage is sometimes interpreted as Jesus' endorsement of the Christian responsibility to state authorities. It has been interpreted as affirming the obligation to pay taxes and participate in the processes of government. In fact, Jesus neatly avoided the direct question put to him and never gave a response to the question of paying taxes. Rather, he made the question a much broader one and reminded people that their first obligation was to God, not the state. It is an excellent example of the need for critical interpretation of scripture. A simple, literal reading of this text leads us to drawing simple, literal conclusions about whether or not we should be paying taxes.

#### **Equality for Faith Petition**


Dear Parishioners of St Finbar's,

"Christ is always present in his Church, especially in its liturgical celebrations. He is present in the sacrifice of the Mass, not only in the person of his minister, 'the same now offering, through the ministry of priests, who formerly offered himself on the cross' but especially under the Eucharistic elements. By his power he is present in the sacraments, so that when a man baptises it is really Christ himself who baptises. He is present in his word, since it is he himself who speaks when the holy Scriptures are read in the Church. He is present, lastly when the Church prays and sings, for he promised: 'Where two or three are gathered together in my name, there am I in the midst of them'" (Mt 18:20).

[Vatican Council II, Constitution on the Sacred Liturgy (1963) art. 7]

If parishioners pray at home at the same time they would normally be together praying at Mass, there is a very real sense in which two or three are gathering in Christ's name, in the unity of their prayer rather than of their physical person. Individual and family prayer based on the Liturgy of the Word at Mass, the Liturgy of the Hours and other sources provides members of parishes and families with an opportunity to honour Christ's presence in the domestic Church as those present pray to God in thanksgiving for gifts received, and for the needs of the Church and the world.

## Petition to the Premier of Victoria

## EQUALITY FOR VICTORIA'S PEOPLE OF FAITH

Dear Premier Daniel Andrews,

We, people of Victoria's faith community, request that the 'Roadmap for Reopening' be amended so that people of faith and places of worship are treated equitably and fairly.

The 2016 national census indicates that approximately 60% of Victorians identify as religious. For people of faith, the ability to practise our beliefs – including through public worship – is essential to our wellbeing. As it stands, the 'Roadmap' suggests that our wellbeing has not been given due consideration.

We are particularly concerned about the inequitable treatment of people of faith under 'Step 3' of your 'Roadmap'. For example, 'Step 3' permits cafes and restaurants to seat up to 20 people indoors and 50 people outdoors yet restricts religious communities to outdoor gatherings of only 10 people and indoor private worship to household bubbles.

There is no logical reason for this discrepancy. People of faith are able to attend a service in a place of worship whilst wearing a face mask; physical distancing is not a challenge in what are often very large venues; services are time-limited and rigorous infection-control measures are able to be implemented. A place of worship can and should be accessible in a COVID-safe way.

Religious organisations should be afforded the same opportunity to open for indoor worship with density quotients equivalent to those seen in other parts of the community such as hospitality. We were afforded the opportunity as we emerged from the first lockdown; we deserve to be afforded the same opportunity again as we emerge from the second lockdown.

Premier Andrews, we, people of Victoria's faith community, request that you adjust the 'Roadmap for Reopening' in a way that secures the equitable treatment of religious communities and grants us the opportunity to practise our faith in a COVID-safe manner.
